The European project **WE Frame: Collective Views for Equality** focuses on the principle of gender equality and aims to explore its contents – and also its critical issues – from an intergenerational and intersectional perspective.

The project is **co-funded by the European Commission** with a budget of €260,920.00 under the CERV Programme: Citizens, Equality, Rights and Values - Call CERV-2024-CITIZENS-REM-EUINTEGRATION, Grant Agreement No. 101196808, aimed at promoting human rights principles and European values. The project coordinator is the Department of Law of the University of Ferrara, which works together with European partners: Officine Europa APS (Ferrara), CDS - Centro Ricerche Documentazione Studi Economico Sociali ODV (Ferrara), Traces&Dreams AB (Sweden).

The **main objective** is to encourage dialogue between people of different generations, activists and scholars, in order to explore issues that animate the contemporary feminist debate on women's rights, identity and gender, raising awareness of the characteristics, content and challenges of the principle of equality.

These objectives will be achieved through a series of **online events and in-person workshops** in the city of Ferrara. The project will conclude with the **WE Frame Festival**, featuring a series of short films by young European directors addressing gender issues.

The project will run for 16 months, from April 2025 to July 2026.
